# Why don't you think once aga

Advise you to give yourself up to the immigration bureau to return your country. If you (an illegal resident) want to return your country, you must appear to the immigration bureau. You can go home without any restriction by deporting order.

Procedures of voluntary appearance are as follows:

- 1 .Identification documents such as passport, police certificate, and others are required (they must be not copies, but original ones), when you appear to the office.
- 2 . On that day, you are taken your picture and fingerprint, and asked a few questions. Then, you are notified the date to come to the office next time and to return your country. You can go home
- 3. You must get an air ticket dated specified by immigration office and its receipt, and bring them to the office on the second time



### **INFORMATION**

### What is "overstay"?

Overstay means an illegal resident who stays in Japan after exceeding the permitted period of stay. There are two cases of overstay.

### Case 1 Illegal entry

Foreign residents who entered Japan with false passport, giving false name, age or nationality fall under illegal entry. Those who entered Japan without immigration inspection are also included

### Case 2 Illegal stay

Foreign residents who entered Japan legally, but stay here after exceeding the permitted period of stay fall under illegal stay.

If foreign residents in both cases are found, they are arrested, put a trial and deported.

Those foreign nationals are prohibited entry for five years by the current immigration law.

Recently, they say that five years of re-entry prohibition will be shortened, if you get married with Japanese.

But it is only a rumor and there is no action.



## Voluntary Appearance

Illegal residents are arrested and deported by the Immigration Law dated February 18th, 2000. If you appear voluntary, you can re-enter Japan after one year. It is your own choice.
