Don't forget about "Application for re-entry permit"

You may not be permitted to return Japan?!

"Fujimino International Cultural Exchange Center" provides foreigners "life consultation" (Mon-Fri) with an aim of improving their life in Japan. This issue introduces you story that some foreigners tried to return Japan without "Application for re-entry permit" and found very difficult to be back to Japan. Even you complete this application, please be noted that re-entry may not be permitted if you have criminal record, or illegally stayed or overstayed in the past. In addition, there have been some people who complete the application, but leave Japan without taking their children. In such case occurred in the past, Child Guidance Center took responsibility to take care these children till the parents returned. Below is a brief introduction for "Application for re-entry permit"

• What is re-entry permit?

While you are qualified to stay in Japan, "re-entry permit" is required before you leave Japan temporarily. Then, you are allowed to return Japan with the same qualification as before.

- Types of re-entry permit
 - ① valid only for 1 time ②valid for multiple
- Please remember...
 - ① Without this permit, you will be no longer able to stay in Japan, no matter what visa you have including permanent residence and special permanent residence.
 - 2 You have to return alien card if you leave Japan without re-entry permit.
 - ③ If you are on probation, re-entry permit is basically not granted. However, it is negotiable depending on your circumstance. If you are student, your school has to allow you to leave Japan temporarily.
 - Otherwise, you would not get re-entry permit.

- When and where we can apply for re-entry permit?
 - ① Most applicants can have the permit on the day they apply. But in some cases, the permit is not granted.
 - ② For urgent case, you can also apply in airport. But only one time is allowed.
 - 3 Application place is immigration office near you.
- Required documents are...
 - ①Application form ②Passport ③Acceptance letter from school if student ④Acceptance letter from company if your pupose of residence is training ⑤Acceptance letter if your purpose of residence is entertainment (long-stay residents like athletes are excluded) ⑥If you continue short-stay for job-hunting purpose, a copy of reference letter from your highest academic institution is required.

Application for "Japanese Language Proficiency Test" has begun.

In Japanese language classes, there are many people who try to challenge "Japanese Language Proficiency Test". Several students of Fujimino International Cultural Exchange Center, Japanese Language Class have passed the test every year. It is your turn to feel joy to pass the test. The application is accepted from **August**

1 (Friday) 2008 to September 12 (Friday).

You can get the form at any major bookstores. It costs ¥500.

It is December 7 (Sun) 2008 held in 25 prefectures

The test fee is ¥5,500 (tax included)



There are four levels of difficulty. You can choose an appropriate level for your Japanese Language skill.

What kind of questions raised in the test? What score should I obtain to pass the test?

At all levels, the test is comprised of writing-vocabulary (Grammar, Kanji, phrases) for 100 points, listening for 100 points and reading-grammar for 200 points. The test level starts from level 4 (beginner) to Level 1 (advanced) and the passing score is set at 60% for Level 2, 3, 4 and 70% above for Level 1.



Do you know "Book Start Project"?

"Book Start Project" targets all babies, who come to have 12 month medical check on purpose to make them familiar with book.

Those babies are given "Book Start Bag" with a picture book (as picture). This project encourages mothers to read such book to children and make a lot of memories through it.
