
The necessary procedure for transfer your driver's license is different depending on your country of origin. First of all, please consult Driver's License

Center.

★There is a examination when you transfer your foreign driver's license to a Japanese one.

When you want to transfer your foreign driver's license to Japanese ordinary motor vehicle license (Grade 1 license), you need to pass the exam of transfer.

The procedure of the exam is Documentary examination, Aptitude test, Confirmation of knowledge and Confirmation of driving skills.



- The necessary procedure for transfer your driver's license is different depending on your country of origin. First of all, please consult Driver's License Center and receive an adequate explanation.
- 1 Requirements
 - a. A valid foreign driver's license
 - b. A Japanese translation of the foreign driver's
 - c. Certificate of Alien Registration
 - d. Passport
 - e. A photograph (3 cm long × 2.4 cm wide)
- ② Application Fee

It varies with the type of your driver's license.

3 Issue Fee

2,100 yen (For listing two types of licenses in one license certificate: 200 ven)

- Documentary examination · · · It is not accepted when you does not fit the requirements or there is a defectiveness in the document.
- Aptitude test···Eyesight test, Audibility test, Athletic ability test
- ullet Confirmation of knowledge \cdots Examination of basic traffic rule of Japan
- Confirmation of driving skills ··· Your practical driving skills will be examined by driving a car in the examination place. The examiner specifies the car you drive. Consideration to your road safety also is checked.

You can't ask questions except when you can't understand the driving route while you take an exam. If you have a smell of alcohol or thinner, or you are a drug user , you can't take the examination.

To drive safely in Japan

Guide of transfer of foreign driver's license to Japanese one issued by Driver's License Center

The following is a part of a basic traffic rule of Japan. Please use it to drive safely.

1. Left-hand traffic...You have to drive on the left-hand side 2. Giving a left-turn or right-turn signal 30m ahead of an intersection 3. Prohibition of drunk driving (The drunk driving penalty are stricter than you think. You have to keep in mind. by The editorial desk) 4. Speed-limit...The legal speed limit is 60km/h for Ordinary/Large-sized motor vehicle and Motorcycle,30km/h for Moped. 5. Railroad Crossing...You have to stop and look right and left 6. Make sure of a traffic light 7. Stop at stop signs 8. Check that all the people are wearing seatbelts 9. Make sure of No parking/Stopping sign

Electronic System for Travel Authorization (ESTA)
Becomes Mandatory

As of January 12, 2009, People who plan to travel to the United States for temporary business or pleasure under the Visa Waiver Program will need to receive an electronic travel authorization before your travel.

All eligible travelers who wish to travel must apply for authorization using the following process: ① Complete your Application②Submit your Application
