

A character of Japanese pension system is the universal pension coverage. It provides the old-age pension when you become old. If you are employed by a company, the amount of pension is deducted from monthly paycheck. Do you know that you can receive a lump-sum pension refund after you return to your homeland?

Refund of pension payments upon location

leaving Japan

Are you paying into a Japanese pension scheme? If you are employed by a company, and are covered by employees pension insurance systems, your contribution is deducted from your salary. The pension systems provide the monthly old-age pension when you are retired. However, if you are planning to return to your homeland before mandatory retirement, you may file a claim for the Lump-sum Withdrawal Payments. The payments amount is determined based on the number of your contributed months. You need to file a claim within 2 years after you leave Japan. After you leave Japan, please complete your claim form carefully and send it to the Social Insurance Operation Center together with passport photocopy (page(s) showing date of your final departure from Japan, your name, date of birth, nationality, signature and resident status), information of bank account and pension handbook. Remember, you can file a claim AFTER YOU LEAVE JAPAN. To apply for it, you need to satisfy the following conditions.

1) You do not possess Japanese citizenship. 2) You have directly paid National Pension Insurance contributions as an insured person for a total of six months or more or have paid Employees' Pension Insurance contributions for six months or more.

3) You do not have a place of residence in Japan.

4) You have never been qualified for receipt of pension benefits. (including Disability Allowance). For details, please visit a multilingual website:<u>http://www.sia.go.jp/e/lw.html</u>

There are several countries (Germany, U.S.A., Belgium, France, Canada, Australia and etc.,) that have international social security agreements with Japan. Under social security agreements, you are allowed to combine the enrollment periods of both countries' systems to qualify to receive benefits. However, if you receive the Lump-sum Withdrawal Payment, the period corresponding to the paid amount cannot be summed up.



Please calculate carefully because the refund is not always a good thing. The U.K. and Korea have social security agreements with Japan to prevent workers contributing to social security pension schemes in both countries at the same time.

New Carry on baggage regulations for domestic flights

The new regulations, which go into effect in December 1st, will be applied to all carriers.

The details are as follows.

(1) For a plane with more than 100 seats, the total dimension of a carry-on baggage must be 115 cm or less.

(The dimensions are 55cm height × 40 cm width× 25 cm depth.)

(2) For a plane with less than 100 seats, the total dimension of a carry-on baggage must be 100 cm or less. (The dimensions are 45 cm height ×35 cm width × 20 cm depth.)

If a baggage does not satisfy the above conditions, it becomes a checked baggage.

HOW TO PREVENT BICYCLE THEFT

The number of stolen bicycles is increasing in 2 cities and 1 town. Most bicycle theft occurs near Station. Here are 3 tips for how to prevent bicycle theft.

 \bullet 1 – Use two locks such as a cylinder type key and a locking cable.

• 2 -Lock your bicycle even if you are only leaving it for a short period of time.

• 3 - Register your bicycle. Registering your bicycle greatly increases the probability it will be found.
