Children are our most precious treasure. To reduce pregnancy and childbirth expenses, the system of lump-sum allowance for childbirth has changed.

## ★The amount and payment procedure of the lump-sum allowance for childbirth and nursing have changed.

Do you have health insurance?

Payment for medical services is expensive. If you do not have health insurance, you have to pay all the cost. However, if you have it, you only have to pay small amount of the cost. In Japan, enrollment in a health insurance plan is mandatory.

You are enrolled in Employee's Health Insurance if employed by a company or organization. National Health Insurance is mainly for people who are self-employed. Upon joining, dependents are also covered.

By the way, normal childbirth is not covered by insurance because it is not disease. However, you may get medical help when you give birth. In that case, you have to pay a lot of money. To reduce the burden, the lump-sum allowance for childbirth and nursing is provided after childbirth.

If you have health insurance, the benefits will be paid from health insurance organization upon application after childbirth. Under the previous system, the household of a mother had to prepare the quite a large sum of money in advance to make first payment to medical institution.

The system has changed since last autumn. Benefits will be paid directly to the medical institute in which a mother gives birth.

Under the new system, childbirth expenses will be paid to the medical institutions directly from health insurance organization. It means that you do not have to prepare a large sum of money in advance.

Please note that some medical institutions do not accept direct allowance payments. (The medical institution is required to explain it to a mother.) In this case, you can receive the benefits through a previous method. The childbirth expenses will be paid upon application after childbirth. So you need to prepare necessary expenses in advance. If medical institution that you are visiting does not adopt the new system and you cannot afford to pay childbirth expenses, please consult the medical institution. The payment might be postponed until you get the lump-sum allowance. Also, you might be able to make use of a loan from insurance organization or social welfare council, etc.

The amount of the lump-sum allowance has also changed since last October. It was increased to 420,000 yen. The additional sum is 40,000 yen. If childbirth expenses are less than 420,000 yen, you can receive the balance upon application. (If childbirth expenses are over 420,000 yen, you need to pay the balance.)

Also pregnancy checkup system has changed. Those who got pregnant will be able to have health checks fourteen times for free of charge.
