

Don't Decide Your "Inheritance Problems" Alone

What is inheritance?

Inheritance is the process of passing on property from a spouse or relative. There are two types of inheritance: legal heirs, designated by law as heirs and "bequests to nonlegal heirs. Legal heirs are defined by the "scope and priority of heirs". The person with the highest priority is the "heir".

Foreign nationals are also heirs if the "Scope and order of heirs" applies.

In Japan, inheritance is carried out in accordance with Japanese law if the deceased decedent was a Japanese citizen. Even foreign nationals have the same rights and obligations to inherit property as heirs of Japanese nationality.

Inheritors	Order
Spouse is always heir (1/2 of estate)	
Children/grandchildren	$1^{\rm st}$
(If no children, grandchildren)	place
Parents (If there are no parents) Grandfather/Grandmother	2 nd place
Brother or sister of the deceased (If there are no brothers or sisters,	3rd
then) nephews and nieces	place

There is a risk to inheritance



Inheritances vary and

depend on the kind of person the decedent was. When we think of inheritance, we think of cash, deposits, buildings, securities, etc., but it may involve obligations and risks in some cases. If the decedent was the head of a farm household, inheriting fields or forest may create obligations and risks to manage them. In some case you have to inherit negative assets such as debts or loans.

Renunciation of inheritance is an act of contract


If the property to be inherited is more negative, or if there are obligations that will become burdensome in the future, or if you are returning to your home country because of the death of your husband you can renounce your inheritance. Disinheritance is a contractual act and cannot be changed later. Consult a legal professional or a friend when you inherit (or disinherit). Do not easily affix your seal or agree to sign anything.

How can I consult a legal professional?

It is especially complicated if the heirs are foreign nationals. Legal professionals are lawyers and judicial scriveners. If you do not have a contracted specialist, you can use "Houterasu (free legal consultation center). You can also utilize free legal advice from the local government.

If you need translation or interpretation services related to inheritance, Fujimino International Cultural Exchange Center will assist this service for a fee.

What should I do if I lost my residence card or passport?

Foreign nationals 16 years of age or older must carry their residence card with them at all times. If you lose your residence card or passport, go to a police station or police box immediately to report the loss and obtain a "certificate of acceptance". Take the certificate to the embassy of your nationality in Japan for reissuance. For details, consult Foreign Residents Information Center (Tel. 0570-013904).
